MEMORANDUM OF UNDERSTANDING

Bharat Vikas Parishad, Madhav Shakha, Karnal (NGO), THE SECOND PARTY, and represented herein by its President, **Mrs. Payal Anand Chaudhary,** (hereinafter referred to as "Second Party", company which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators, and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

WHEREAS:

- First Party is a women degree college named **Kumari Vidyavati Anand DAV College for Women, Karnal, Haryana.**
- Second Party is an NGO named **Bharat Vikas Parishad, Madhav Shakha, Karnal, Haryana.**
- Mrs. Payal Anand Chaudhary,** President, BVP, Madhav Shakha, Karnal; **Mrs. Gauri Datta,** Secretary, BVP, Madhav Shakha, Karnal; & **Mrs. Sujata Gupta,** Executive Member of BVP, Madhav Shakha, Karnal & Former Principal, Kumari Vidyavati Anand DAV College for Women, Karnal, Haryana will act as the Coordinators between the First Party & Second Party.
- First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- The Parties intent to cooperate and focus their efforts on cooperation within area of Lectures, Guidance, Counselling & Sensitization Programmes on Women Empowerment, Cyber Crime, Health Care, Legal Literacy, Defence Career, Community Service & Extension Activities (Pickle-making, Stitching, Embroidery, Cosmetology, etc.)


NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE THAT:

Duration of MOU: For One Year (From 21/02/2024 to 20/02/2025)

Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.

RELATIONSHIP BETWEEN THE PARTIES

It is expressly agreed that **Kumari Vidyavati Anand DAV College for Women, Karnal, Haryana** and **Bharat Vikas Parishad, Madhav Shakha, Karnal (NGO)** are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
